## **Registration Deadlines Pass, but FEMA is Still Here to Help**

*Wildfire Survivors Should 'Stay in Touch' with FEMA*

**SACRAMENTO, Calif.** – The deadlines for survivors of wildfires included in two federal disasters to register with FEMA for aid have passed, but that does not mean FEMA is leaving. The agency continues working with the California Governor's Office of Emergency Services to help them and their communities recover.

If you have registered for assistance, FEMA encourages you to keep in touch to track your case or to notify the agency of changes to your mailing or email addresses or phone numbers, and to report insurance settlements or additional damage you may have discovered since your home inspection.

Here's how to reach FEMA:

- Online at [DisasterAssistance.gov](https://www.DisasterAssistance.gov).
- Download the [FEMA app](#) to a smartphone or tablet.
- Call 800-621-3362 (TTY: 800-462-7585) between 7 a.m. and 8 p.m. PST, seven days a week. Those who use a relay service such as a videophone, InnoCaption or CapTel, should provide FEMA with the specific number assigned to that service when they register. Multilingual operators are available.

When updating status information, refer to your nine-digit number issued at registration. This number is on all correspondence you receive from FEMA and is a key identifier in tracking assistance requests.

The deadline to register with FEMA for disaster assistance for Disaster 4558 was Dec. 11, 2020. This is for August/September wildfires in the counties of Butte, Lake, Lassen, Mendocino, Monterey, Napa, San Mateo, Santa Clara, Santa Cruz, Solano, Sonoma, Stanislaus, Trinity, Tulare and Yolo.

The deadline to register with FEMA for disaster assistance for Disaster 4569 was Dec. 16, 2020. This is for later fires in the counties of Fresno, Los Angeles, Madera, Mendocino, Napa, San Bernardino, San Diego, Shasta, Siskiyou and Sonoma.

The deadlines to apply for a physical disaster loan from the U.S. Small Business Administration (SBA) have also passed, but there is still time for small businesses to apply for an Economic Injury Disaster Loans (EIDL). For Disaster 4558 the deadline to apply for an EIDL in these counties is May 24, 2021. For Disaster 4569 the deadline to apply for an EIDL in these counties is July 16, 2021.
