



Public Health Requirements: Recreational Vehicles and Mobile Homes Temporary Wastewater Disposal & Proof of Potable Water - Woolsey Fire Area

WASTEWATER DISPOSAL - Land Use Program (626) 430-5380

To obtain approval from the Department of Public Health (DPH) for wastewater disposal from a recreational vehicle or mobile home used for temporary housing in the Woolsey Fire area, please submit the following documentation for review and approval.

Recreational Vehicles (RVs) including, but not limited to: motorhomes, campervans, fifth-wheel trailers, popup campers, truck campers, etc.	Option 1	Approval to utilize the existing septic system* on the property: <ul style="list-style-type: none"> Have the septic system evaluated by a Qualified Contractor (QC) and complete the "Evaluation Form for Existing OWTS Project Reviews". <ul style="list-style-type: none"> A QC is an individual who possesses a valid California License as: Class A, Class B, C-42, C-36 and Submit an application, the completed system evaluation, any previous DPH approval(s)** and the associated fee to the Land Use Program (LU). <p>The Application and Evaluation Form may be found on the DPH website at: http://publichealth.lacounty.gov/eh/EP/lu/lu_main.htm or call 626.430.5380.</p>
	Option 2	Approval to have the holding tank of your RV pumped, provide proof of a valid contract with a sewage pumping company that is licensed to pump in Los Angeles County.
	Option 3	Approval to dispose of wastewater on your own, provide the name and address of the proposed RV Sanitation Dump Station you plan to use.
Mobile Homes	Approval to utilize the existing septic system on the property: <ul style="list-style-type: none"> Have the septic system on the property evaluated by a Qualified Professional (QC) and complete the "Evaluation Form for Existing OWTS Project Reviews". <ul style="list-style-type: none"> A QC is an individual who possesses a valid California License as: Class A, Class B, C-42, C-36 and Submit an application, completed system evaluation, previous DPH approval(s)** and the associated fee to the LU Program <p>Application and Evaluation Form may be found on the Department's website at: http://publichealth.lacounty.gov/eh/EP/lu/lu_main.htm or call 626.430.5380.</p>	

*Only septic systems with a prior approval from DPH or the local Building and Safety Department (B&S) are eligible for use with temporary vehicle housing.

**If you do not have a copy of previous approvals, you may contact the LU Program or B&S to request a copy of prior septic system approvals issued regarding the subject property.

PROOF OF POTABLE WATER - Drinking Water Program (626) 430-5420

Local Building and Safety departments require homeowners to provide a Water Availability Letter (Water Letter) from DPH. To obtain a Water Letter, you must provide proof that the property has a reliable source of on-site potable water.

To provide proof of potable water and receive a Water Letter: <ul style="list-style-type: none"> Submit a copy of your latest water bill to the Drinking Water Program if you are serviced by a water utility (e.g. Waterworks Districts, Las Virgenes Municipal Water District, etc.) or If you receive drinking water from a water well located on your property: <ul style="list-style-type: none"> Complete the Well Reuse Application available on the DPH website at http://publichealth.lacounty.gov/eh/EP/dw/dw_main.htm and <p>Submit the completed form to the Drinking Water Program for review and approval.</p>
